**I understand that I must contact Brown County Dispatch by telephone (920) 391-7470) and the Fire Chief (920) 655-3719) before I start burning.**

**\*Burning Times Permitted\***

**Monday through Friday: no open burning shall be permitted before 4:00 p.m. or after 8:00 p.m.; Saturday: no open burning shall be permitted before 8:00 a.m. or after 8:00 p.m.; Sunday: no open burning shall be permitted on Sunday or a holiday. All open burning shall be completely extinguished before being left unattended or when winds exceed 15 mph. Burning is discouraged during afternoon hours because of potential winds.**

**This permit shall be available at the burn site while burning, and it must be shown upon request of an appropriate official.**

**Open Burning Requirements:**

1. A burning permit shall only be issued for property located within agricultural districts, which are the A-1 and A-2 Districts, or property that consists of a minimum of 2.5 acres
2. No recreational fire or cooking fire shall be permitted during periods when either the Village, the Department of Natural Resources or the Village of Hobart Fire Department has issued a burning ban (the "burning ban"), which may be issued based upon one or more of the prior party's discretion.
3. Construction materials, treated or painted woods, trash, any plastics, tires or similar dense or toxic smoke producing substances are prohibited from being burned.
4. Open burning is prohibited within 30 feet of any structure.
5. A responsible person, over 18 years of age, must attend open burning at all times.
6. Adequate fire control equipment (shovels, water, fire pumps) must be kept on site and available while burning.
7. Should the open burn spread out of control or off of the burn property, and fire extinguishment becomes necessary, the owner agrees to pay for any resources that may be needed to control and extinguish the fire.
8. The Village of Hobart and the employees thereof, in issuing a permit, assume no liability or responsibility for any hazardous situation created by the applicant or any damage that may occur as a result of open burning.
9. The Fire Chief or designee has the discretion to extinguish an open burn at any time for any reason.
10. No open burning may include burning trees or shrubs, unless such trees or shrubs have been cut down and cut into segments 4 feet or smaller.
11. Smoke from any cooking fire or recreational fire may not create a nuisance for neighboring property owners. Refer to Chapter 207, Nuisances, Article I, for definition of "nuisance."

**If your fire gets away, you will be liable for all expenses incurred in suppressing the fire and will be responsible for all damages caused by the fire and penalties as outlined in Municipal Code Chapter 127-11.**

**I understand this permit is invalidated upon violation of any of its restrictions, or upon the burning of material not authorized by this permit, and may be canceled when deemed necessary.**
